Community Engagement

Our proposed plan was developed based on previously identified school needs through our annual LCAP process. The administrative team identified priorities that were not able to be funded from other funding sources and ranked those priorities based on needs identified in the current school year. On 9.7.21 we attended a virtual meeting open to all community members. Participants included stakeholder groups such as CalWORKs, behavioral health, health and human services, probation, and youth outpatient services. These community groups, who represent traditionally underserved populations, students with disabilities, English learners, homeless and foster youth, migratory students, and students part of the juvenile justice system, previously reviewed highlights of our proposed plan and provided feedback and suggestions on areas of concern they see with the student and family populations they serve. Meetings for the ESSER III plan were open to all community members. No participants stated they were representing specific tribes or civil rights organizations. We reached out to two civil rights organizations but did not receive phone calls back. Sky Mountain Charter School has determined that tribes are not present nor served by

this LEA, and we do not have local bargaining units. On 9.14.21 we held a virtual feedback session that was open for all educational partners, including but not limited to: parents, families where English is not the first language, students, teachers, general education administrators, special education administrators, school leaders, other educators, school staff, and community members. We reviewed our proposed plan and gave access to attendees to write comments and suggestions on our proposed plan. The meeting was recorded and sent via listserv to our entire school community to watch the recording at a time and location that was accessible for them. Those watching the recording were able to provide feedback on the plan through email. Two additional meetings were held with our administrators. One with our business leadership team and one with our educational leadership team. These groups reviewed all of the feedback to look for trends and compare to what we offer through our LCAP as well as provide their own suggestions based on data review. The plan was submitted to our governing board in September for review, discussion, and approval.

A description of how the development of the plan was influenced by community input.

The basis of our plan was built upon the knowledge gained through our annual LCAP process of identifying school and student needs and receiving stakeholder feedback on the development of ensuing goals and actions. From the external community partners, the biggest need they identified is increased mental health and behavioral needs of students. This shaped our section "use of any remaining funds" to include increased socio-emotional learning and mental health supports for our students. Our school community stakeholder feedback echoed this request for more mental health opportunities for our students. Both groups said that students need help to manage their anxiety and depression. We plan to offer a school-wide socio-emotional learning program that parents can implement with their children or students can do by themselves, to help them manage their emotions. The largest area of feedback from our school community stakeholders surrounded the category "addressing lost instructional time". There was clear and significant feedback that they continue to want flexibility when it comes to supplemental educational resources and options for student interventions. Because of this we are devoting part of our ESSER III funding to provide additional instruction and supplemental curriculum and learning supports for our students. We are doing this in two primary ways: our teachers will begin offering synchronous classes covering a variety of content areas to support student learning, and we are increasing our intervention program small group tutoring to include additional subject matters and to include students identified as Tier 2 based on their performance on our internal assessment.

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.
